Who is subject to the Food Safety Modernization Act (FSMA)? Lynn Brandenberger

The Food Safety Modernization Act was passed in 2011 and the final Produce Safety rule for FSMA went into effect in November of 2015.

There has been some confusion about whether or not specific farms will be required to adhere to the



rule for produce safety hopefully we can help clear that up. First, there are exemptions based on the amount of sales that a farm has had. Farms that have average sales during the past three years of less than \$25,000 per year are considered exempt. Farms that have sales averaging more than \$25,000, but less than \$500,000 and that sell a majority of their produce to qualified end users (consumer, restaurant or retail food outlet) within the state or not more than 275 miles from the farm are also considered exempt.

That said, even exempt farms will need to prominently display their farm name and business address where the produce was grown on the produce label or at the point of

purchase.

Regardless of whether a farm is exempt or not, all growers should be using food safety practices during production, harvest, and after harvest to ensure the safety of all produce that they are responsible for.

We'll be sharing more about the Food Safety Modernization Act in future newsletters.
